In addition, Harris serves as investment adviser to Harris Associates Investment Trust (the "Trust"), and various of Harris' officers and directors are also officers and trustees of the Trust. Harris does not consider that the Trust is controlled by such persons. Shares beneficially owned by the Trust, through its various series, are included as Shares over which Harris has shared voting and dispositive power and thus as Shares beneficially owned by Harris, because of Harris' power to manage the Trust's investments. In addition, Harris serves as investment adviser to a small number of other clients who may own Share, but for which does not have discretionary authority. Nevertheless, the Shares may be included in the aggregate number of Shares over which Harris has shared voting and shared dispositive power reported herein, although Harris may not be deemed the beneficial owner (as defined by Rule 13d-3) of such shares.
