

## White Mountains Repurchases 282,341 Shares for \$500 Per Share

HAMILTON, Bermuda, Oct. 26 /PRNewswire-FirstCall/ -- White Mountains Insurance Group, Ltd. (NYSE: WTM) announced today that it repurchased 282,341 of its shares for \$500 per share in a transaction with an institutional investor. This transaction is the first repurchase under the previously announced share repurchase plan authorized by White Mountains' Board of Directors on November 17, 2006. There are 717,659 shares remaining for future share repurchases under the plan.
