Explanation of Responses:

(1) Represents shares held in a Grantor Retained Annuity Trust (the Jack Byrne 2001 Grat No.1) dated May 15, 2001 (the "Trust"). The Reporting Person originally contributed a total of 650,000 shares into the Trust on May 15, 2001. At December 31, 2002, 380,909 shares remain in the Trust following a 2002 mandatory distribution. The remaining shares in the Trust continue to be beneficially owned by Mr. Byrne indirectly.

(2) The information in this report is based on a plan statement dated as of March 31, 2003.

(3) Represents 277,300 shares contributed by the Reporting Person to a Grantor Retained Annuity Trust (the Jack Byrne 2003 GRAT No. 1 (the "2003 GRAT No. 1")) on March 14, 2003. The shares held in the 2003 GRAT No. 1. continue to be beneficially owned by Mr. Byrne indirectly.

(4) Represents 50,000 shares contributed by the Reporting Person to a Grantor Retained Annuity Trust (the Jack Byrne 2003 GRAT No. 2 (the "2003 GRAT No. 2")) on April 8, 2003. The shares held in the 2003 GRAT No. 2 continue to be beneficially owned by Mr. Byrne indirectly.
