- Payment of deferred compensation balances is due in cash based on a predetermined Payment Schedule entered into in October 1999 by the Reporting Person.
- Dividends are automatically invested in Phantom Shares at the fair market price per share of the underlying WTM Common Shares on March 24, 2004, the date the dividends are deemed to be paid.
- The Phantom Shares are payable, at the election of the Company, in cash or Common Shares following the Reporting Person's resignation as a Director of the Company or beginning at a date selected by the Reporting Person.
