Explanation of Responses:

- 1. Since February 4, 2005, the date of Reporting Person's last filing, Reporting Person acquired 6 shares of WTM's Common Shares under the Folksamerica 401(k) Plan. WTM Common Shares are purchased at fair market value on the date of purchase. The information in this report is based on a plan statement dated as of February 28, 2005.
- 2. Phantom Shares are convertible into Common Shares on a 1 for 1 basis.
- 3. On March 23, 2005, the Reporting Person's deferred compensation account was credited with Phantom Shares equal in value to the ordinary dividend paid on the underlying WTM Common Shares on the dividend date.
- 4. Payment of deferred compensation balances is due in cash based on a predetermined Payment Schedule entered into in October 1999 by the Reporting Person.
- 5. Dividends are automatically invested in Phantom Shares at the fair market price of the underlying WTM Common Shares on March 23, 2005, the date the dividends are deemed to be paid.
- 6. The Phantom Shares are payable, at the election of the Company, in cash or in Common Shares following termination of the Reporting Person's employment with the Company or beginning at an earlier date selected by the Reporting Person in accordance with the terms of the deferred compensation plan.
- 7. On February 28, 2000, the Reporting Person was granted options to purchase WTM Common Shares on a 1 for 1 basis at an initial exercise price of \$106.19. The exercise price increases by 6% annually on a cumulative basis

8.
